Agenda

Approval of February 2, 2023 Minutes

1. Updates from Mr. Murphy

New Business

Other Business

Mr. Cronan brought up the idea of adding youth representation to the commission. Mr. Cronan made a motion to look further into the prospect of adding youth representation to the commission. Mr. Atchley seconded the motion and it passed unanimously.
