A meeting of the Human Services Committee was held on Tuesday, June 20, 2023. This was a hybrid meeting held both in person and electronically via ZOOM. The meeting was called to order at 10:17 PM by Chair, Sarah Gallagher.

MEMBERS PRESENT: Sarah Gallagher, Chair; Laurie Sweet; Katie Kiely; Cory O'Brien

MEMBERS ABSENT: Adrian Webber, Vice-Chair; Bob Anthony

Public Input: There was 1 speaker

The following items were addressed:

1. Order authorizing the Brundage Rain Garden and Barrell Installation Project

--Moved by Ms. Kiely and seconded by Ms. Wetmore.

A vote was taken. The item passed unanimously.

2. Order authorizing the Town of Hamden to extend the License Agreement with Yale University

--Moved by Ms. Kiely and seconded by Ms. Sweet. DISCUSSION: Mr. Grace indicated this is a continuation of allowing Yale to use the community room at Brundage Library for programming.

A vote was taken. The item passed unanimously.

3. Order approving and authorizing the Town of Hamden on behalf of the Hamden Public Library to enter into an agreement with Patron Point, Inc.

--Moved by Ms. Gallagher and seconded by Ms. Kiely. DISCUSSION: Mr. Grace indicated this is a continuation of agreement that helps connect Library patrons with services of interest and marketing for programs.

A vote was taken. The item passed unanimously.

4. Resolution authorizing the Town of Hamden to accept the donation of an electric wheelchair (Elderly Services Department)

--Moved by Ms. Sweet and seconded by Ms. Kiely. DISCUSSION: Mr. Grace thanked former Hamden Fire Chief Gary Merwede for this donation.

A vote was taken. The item passed unanimously.

Ms. Gallagher requested a motion to add the following item to the agenda. Moved by Mr. O'Brien, seconded by Ms. Kiely.

5. Order authorizing the Town of Hamden to participate in the State of Connecticut Elderly and Disabled Demand Responsive municipal Grant Program (\$57,919)

--Moved by Ms. Kiely and seconded by Ms. Wetmore.

A vote was taken. The item passed unanimously.
