The following items were addressed:

1. Order approving a donation of property at 2993 Whitney Avenue (Station #5) from the Mount Carmel Volunteer Fire Company, No. 1 and authorizing the Mayor to execute an agreement

-- Moved by Mr. Osmanu, seconded by Mr. Webber. DISCUSSION: Fire Chief Naples thanked Dave Johnson for coming and speaking on this tonight and for all he does. He also thanked the entire Mount Carmel Volunteer Fire Company and said he will continue to respect the amount of history and pride that's in the Mount Carmel Volunteer Fire station which will continue on for years to come.
