A meeting of the Economic & Development Committee was held on Monday August 28, 2023. This was a hybrid meeting held both in person and electronically via ZOOM. The meeting was called to order at 7:47 PM by Ted Stevens, Chair.

The following items were addressed:

**1. Reappointment of Steven Walsh as an alternate to the Zoning Board of Appeals for a term to expire January 31, 2027 (D-7)**

--Moved by Mr. Stevens and seconded by Ms. Sweet **DISCUSSION:** Mr. Farmer asked what is the district representation of this Committee. Mr. Grace said this would be the only 7<sup>th</sup>. There is a member in the 5<sup>th</sup>, two in the 9<sup>th</sup>, one in the 4<sup>th</sup>, and one in the 6<sup>th</sup>. Ms. Gallagher thinks it would be helpful to have a list of other members on a commission with district representation attached to appointments which come before them. Mr. Grace said he would be happy to do that. Mr. Farmer thanked all who serve on our Boards and Commissions.
