A meeting of the Finance Committee was held on Wednesday, September 8, 2021, electronically via Zoom due to the Covid-19 Pandemic. The meeting was called to order at 8:13 P.M. by the Vice-Chair, Jeron Alston.

The following items were addressed:

- 1. Refund of Property Taxes collected between to July 1, 2021 and June 30, 2022  
– (1) totaling \$2,705.38**

-- Moved by Ms. Schomaker, seconded by Mr. Webber and approved unanimously.

- 2. Refund of Property Taxes collected prior to July 1, 2021 – (20) totaling \$8,479.01**

-- Moved by Ms. Wetmore, seconded by Mr. Webber and approved unanimously.

- 3. Refund of Motor Vehicle Taxes collected between July 1, 2021 and June 30, 2022 –  
(23) totaling \$5,527.74**

-- Moved by Ms. Wetmore, seconded by Ms. Schomaker and approved unanimously.

- 4. Resolution of official intent to reimburse expenditures from the proceeds of tax exempt obligations for the planning, design, renovation, improvement,, construction and acquisition of Town roads, parking lots, guardrails and sidewalks; drainage repairs and upgrades; fire department and apparatus; and improvements to the Miller Memorial Library, Brundage Branch Library, and Whitneyville Branch Library in the maximum amount of \$4,630,000**
