There are several vacancies on Hamden's Boards & Commissions that can only be filled by "Unaffiliated", "Republican" or "Minor Party" voters. Because of minor party representation, each commission is limited in the number that can be appointed from any one political party. You have to be a Hamden voter to participate in its Boards & Commissions. All commission appointments must be Mayor recommended and Legislative Council approved. The following commissions have immediate vacancies:

Arts Commission – 3yrs (10/15):

Energy Use & Climate Change Commission – 3 yrs (5/9):

(2) Vacancies - **(Can only be a "U", "R" or minor party.) Not a Dem**

Ethics Board – 5 yrs (3/5):

(2) Vacancies - **(Can only be a "U", "R" or minor party.) Not a Dem**

Fair Rent Commission – 3 yrs (3/5):

(3) Vacancies – One Tenant and Two Citizen Members

(can be any political party, but two **(Can only be a "U", "R" or Minor party**)

(1) Alternate Vacancy (can be any political party).

Farmington Canal Commission – 3 yrs (6/9):

(1) Vacancies– (Can be any political party but only Two can be a Dem)

Fire Commission – 2 yrs (3/5):

(1) Vacancy **((Can only be a "U", "R" or minor party. Not a Dem)**

Hamden Plains Cemetery Committee – 6 yrs (3/5):

- (1) Vacancy **(Can only be a “U”, “R” or minor party. Not a Dem)**

Inland Wetlands Commission – 3 yrs (6/11):

- (1) Vacancy **(Can only be a “U”, “R” or minor party.)**

Personnel Appeals Board – 5 yrs (3/5):

- (1) Vacancy (Can be any political party)

Planning & Zoning Commission – 3 yrs (5/9):

- (3) Full Vacancies (can be any political party)
- (1) Alt Vacancy **(Can only be a “U”, “R” or minor party.)**

Quinnipiac Valley Health District – 3 yrs (3/5): (Leg Council Appt)
